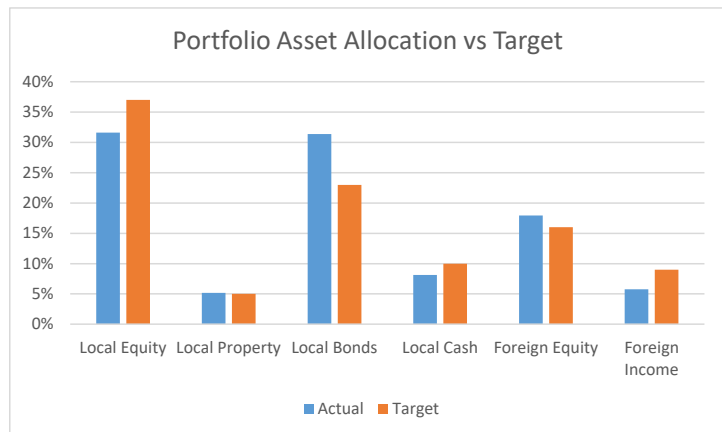


## About the Portfolio:

The RFS Umbrella Fund Moderate Portfolio aims to achieve a return well in excess of inflation. It achieves this by actively managing the allocation to various asset classes and portfolio managers. This portfolio is less concerned with short-term capital preservation. It will over time have a medium allocation to growth assets such as equities.

**Target:** CPI plus 4.5% over rolling 5-years periods  
**Benchmark:** 37% Domestic Equity, 5% Property, 25% Global, 23% Domestic Bonds, 10% Cash  
**Peer Group:** Absolute Return (CPI + 4% to 5%) Portfolios  
**Regulation 28:** Complies

## Asset Allocation:

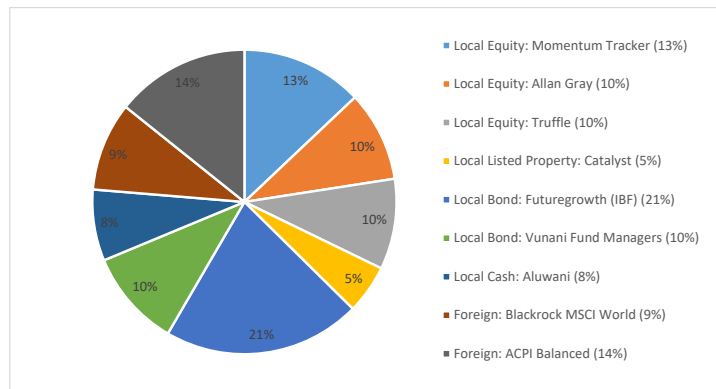


## Portfolio Returns:
