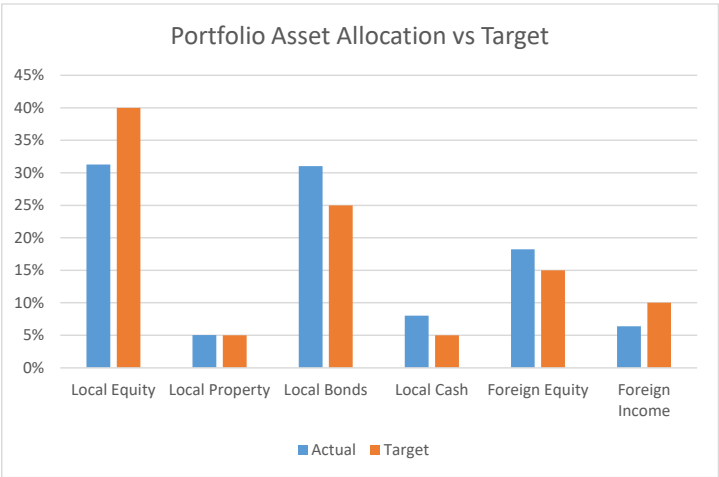


About the Portfolio:

The RFS Umbrella Fund Moderate Portfolio aims to achieve a return well in excess of inflation. It achieves this by actively managing the allocation to various asset classes and portfolio managers. This portfolio is less concerned with short-term capital preservation. It will over time have a medium allocation to growth assets such as equities.

Target: CPI plus 4.5% over rolling 5-years periods
Benchmark: 40% Domestic Equity, 5% Property, 25% Global, 25% Domestic Bonds, 5% Cash
Peer Group: Absolute Return (CPI + 4% to 5%) Portfolios
Regulation 28: Complies

Asset Allocation:

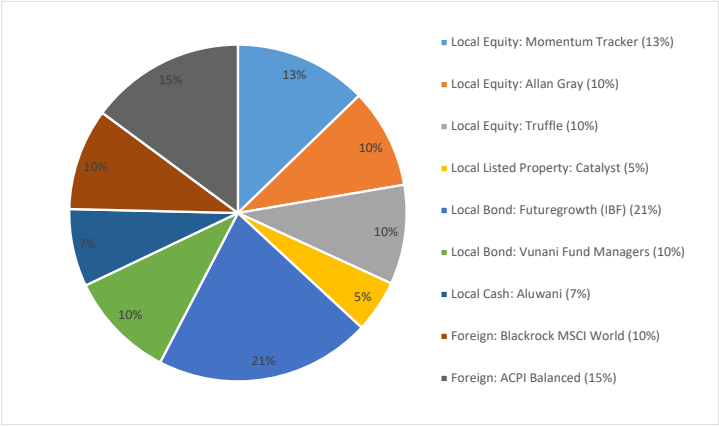


Portfolio Returns:
